Applications are invited, in the prescribed proforma(enclosed), from interested retired OIS(Odisha Information service) Cadre Officers, with following experience, attaining not above the age of 65 years and having good service records and physical fitness for engagement as Officer-on-Special Duty against the vacant post of Information Officer, New Delhi(under Information and Public Relations Department, Govt. of Odisha) to work in the O/o, the Chief Resident Commissioner, Odisha on contractual basis with monthly consolidated remuneration to be fixed by Administrative Deptt in consultation with Finance Deptt as per the terms and conditions as laid down in General Administration Department Resolution No. 23750/ Gen. dated 27.08.2014.

- (i) The re-employment shall be made initially for a period of one year and can be extended for subsequent periods subject to satisfactory performance up to a total period of four years not beyond the age of sixty five years of age, in any case, or till the posts are filled up by regular process, whichever is earlier.
- (ii) The retired officer against whom a vigilance case or departmental proceeding or criminal prosecution is contemplated or pending or who has been penalized for misconduct during the period up to five years preceding his / her retirement, or is a member of a political party will not be eligible for consideration.
- (iii) Re-employment of the officer shall be governed by the provisions of Odisha Government Servants' Conduct Rules, 1957 and shall be liable to be proceeded against for his/ her misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
- (iv) The re-employment can be terminated at any time by the respective appointing authority due to unsatisfactory performance of the re-employed officer by giving one month notice. On the contrary, if any re-employed officer desires to resign he shall do so by giving one month's written notice to the competent authority.
