Department on or before 5.12.2017 by 2P.M. and will be opened by the Tender Committee in the Conference Hall of I & P.R. Department at 4P.M. on the same day in the presence of tenders or their authorized representatives. The vehicles can be inspected at the Office Garage of I & P.R. Department on any working day during office hour along with the documents of the vehicles. The tender should be accompanied with a Bank Draft of Rs.1000/- (Rupees One thousand) only as earnest money in favour of Drawing and Disbursing Officer, I & P.R. Department, BBSR for each vehicles. The tender whose offer will be the highest and accepted by the competent authority shall deposit 25% of the offered amount immediately. The balance amount will be deposited in I & P.R. Department within seven days of confirmation of the bid, failing which the deposit including the EMD shall be forfeited. The tenderer shall be remove the vehicle from the site immediately on full payment of bid amount, in case the vehicle is not removed, custody and safely of vehicle shall be the responsibility of the tenderer and no claim or complaint on that account shall be entertained. On failure to remove the vehicle within stipulated time, ground rent at the rate of 1% of the bid money shall be charged for each day or part of the day for the vehicle till the removal of the vehicle from the site. If the ground rent so charged exceeds the sale price deposited, then the tenderer shall cease to have any right on the vehicle and the amount deposited, then the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent and the vehicle shall become absolute property of the Government.


