#### INFORMATION TO THE BIDDER

#### 1. BACKGROUND AND SCOPE OF THE ASSIGNMENT:

#### Scope of the work:

To provide Common Feeding Systems to different Electronic Media Channels for live coverage of different Government Events/Programmes.

#### Terms and Condition:

- 1. The Agency should have minimum one (1) year of experience in providing Common Feeding System to different Electronic Media Channels. Experience in providing Common Feeding System in Govt. Events will be preferred. (Supporting documents to be submitted)
- 2. The Agency should have capacity to provide Common feeding system at least to 15 nos. of Electronic Media Channels at a time.
- 3. The Agency should have a local office in the State of Odisha with adequate manpower and infrastructure support to handle the Programme/Event.
- 4. The Agency should have
  - i. 3 to 8 setup H.D Cameras broadcast quality with all relevant accessories for Live telecast with manpower for both audio/video .
  - ii. The Agency should have Audio System for Live Telecast, Jimmy Setup, Drone Setup.
  - iii. R.F Cameras (Wireless), range should be 500 meters & above
  - iv. Extra switcher for standby backup, Video output both SD & HD (Splitter for minimum 20 outputs)
  - v. Mixer with good quality microphone preferable Wireless.
  - vi. The bidders must have his/her own setup. (Supporting documents to be submitted)
- 5. Minimum Turnover of the Agency should be at least Rs.50,00,000/-(Rupess Fifty Lakh) only per annum.
- 6. The Agency should have mechanism to provide the Common feeding system in both HD and Standard Format and also mechanism for web media.
- 7. The Agency should deposit a sum of Rs. 1,00,000/-(Rupees One Lakh Only) in shape of Demand Draft in favour of Director, I & PR Department, Govt. of Odisha (refundable) security which can be refunded after successful completion of the assignment during the period of agreement.
- 8. The Agency should maintain confidentiality that all videos shall be Government property and cannot be shared with anyone.
- 9. The period of agreement is for a period of one year from the date of assignment and this can be extended by mutual consent.
- 10. If any of the information submitted by the Agency is found to be false or incorrect in any manner, the Agency cannot be taken into consideration for giving such assignment.

#### 2. RECEIPT OF PROPOSAL:

Towards this end, Expression of Interest is invited from the Agencies to submit their proposals for the above assignment. Proposal will be opened on 20.03.2020 at 4.30 P.M. in the Conference hall of I & PR Department. Proposal may be submitted through Speed Post / Registered Post / Courier to the Director, I&PR Department in the address The Director, Information & Public Relations Department, Government of Odisha, Bhubaneswar, Odisha in a sealed envelope. The last date for receipt of proposals is 20.03.2020 by 3.30 P.M.

#### 3. PROPOSAL VALIDITY:

The Offer submitted and the prices quoted therein shall be valid for one year from the date of opening of bid. Bid valid for any shorter period shall be rejected by the Client.

#### 4. TECHNICAL BID REQUIREMENTS:

The bidder needs to submit the following self certified documents along with the technical bid:

- 1) Copies of the up to date IT Return
- 2) Copy of PAN Number
- 3) Copy of GSTIN
- 4) Documentary evidence regarding local office in the state of Odisha with adequate manpower and infrastructure support.
- 5) An undertaking that the firm is not blacklisted/debarred from any Government organization/Department during the recent past

#### 5. PROPOSAL EVALUATION AND EMPANELMENT:

A two stage evaluation process will be adopted as explained below for evaluation of the bids:

- Pre-qualification Evaluation (1<sup>st</sup> Stage): Preliminary evaluation of the proposals will be done to determine whether the proposals are in order & complete and the requisite documents have been properly furnished by the bidder or not.
- Financial Evaluation (2<sup>nd</sup> Stage): The financial proposals of the bidders only shall be opened at this stage in the presence of the bidder's representative who wishes to attend the meeting with proper authorization letter. The name of the bidder along with the quoted financial price for each component will be announced during the meeting.

The Price Bid has to be submitted as per prescribed Format at Section: 3. Cost Based Selection (CBS) method will be followed during the overall selection process. The client will select the lowest evaluated price bid (L1) among all the bids. The empanelment will be done for a period of 1 year from the date of finalization of rate.
