- 5. The Performance security submitted by the Agencies/Firms shall remain valid till completion of contract period .
- 6. In case of any dispute/ambiguity arises in the documentation ,the decision of I&P.R Department / Tender Committee Authority is final.
- 7. The contract to the agencies includes charges of all the man power which may be required for execution of the assignments.
