1. The appointment is purely temporary and terminable at any time without prior notice and assigning any reason thereof.



2. They should join within 30 (Thirty) days from the date of issue of this order failing which their appointment shall stand cancelled automatically.
3. Acceptance of their joining report shall be subject to submission of the following documents on the date of their joining in the post.
- Medical Certificate of fitness in the prescribed form from a Medical Officer not below the rank of Asst. Surgeon in the State Govt. Service of any Govt. Hospital.
  - Character certificate from two Gazetted officers not related to them.
  - A declaration to the effect that they are unmarried/ married having not more than one spouse living.
  - An oath of allegiance to the constitution of India.
  - Two self –attested passport size photographs.
  - A declaration to the effect that no criminal antecedent/ case is pending against them.
  - Caste certificate/Disability Certificate from the competent authority in case of ST/SC/SEBC/PwD candidates.
  - All original certificates in support of educational qualification and date of birth along with one set of photo copy.
  - A statement showing the movable/immovable property owned by him in Form-I prescribed under the Odisha Government Servant Conduct Rules, 1959. The statement should be submitted in a sealed cover by writing the name, designation, present address and mentioning in bold letters "PROPERTY STATEMENT".
4. The appointment is subject to verification of character and antecedents of the candidate. If any adverse report is received against any candidate, then his/her services shall be terminated forthwith in accordance to Para-4 of G.A. & P.G. Department Resolution No. 34438/Gen, dated 20.11.1999.
