- An oath of allegiance to the constitution of India. iv.
- Two self –attested passport size photographs. V.

- All original certificates in support of educational qualification and date of birth along viii. with one set of photo copy.
- A statement showing the movable/immovable property owned by him in Form-I ix. prescribed under the Odisha Government Servant Conduct Rules, 1959. The statement should be submitted in a sealed cover by writing the name, designation, present address and mentioning in bold letters "PROPERTY STATEMENT".
- 4. The appointment is subject to verification of character and antecedents of the candidate. If any adverse report is received against any candidate, then his/her services shall be terminated forthwith in accordance to Para-4 of G.A. & P.G. Department Resolution No. 34438/Gen, dated 20.11.1999.
