**NOTIFICATION**

**Bhubaneswar, Dated 12th March, 2024**

No. IPR-OE1-CSNG-0001-2023- 4284, In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Odisha has been pleased to make the following rules to amend the Odisha Information and Public Relations Technical and Non-technical Service (Method of Recruitment and Conditions of Service) Rules, 2015, namely:-

**1. Short title and Commencement.—**

- (1) These rules may be called the Odisha Information and Public Relations Technical and Non-technical Service (Method of Recruitment and Conditions of Service) Amendment Rules, 2023.
- (2) They shall come into force on the date of their publication in the *Odisha Gazette*.


**2. In the Odisha Information and Public Relations Technical and Non-technical Service (Method of Recruitment and Conditions of Service) Rules, 2015 (hereinafter referred to as the said rules), in rule 4, in sub-rule (3),—**

- (i) in clause (a), for the words “ninety percent”, the words “eighty percent” shall be substituted; and
- (ii) in clause (b), for the words “ten percent”, the words “twenty percent” shall be substituted.

**3. In the said rules, in rule 6, in sub-rule (3), for clause (c), the following clause shall be substituted, namely:—**

“(c) In order to be eligible for recruitment to the posts mentioned under clause (a) of sub-rule (4) of rule 4, a candidate must have passed ITI in Electricals or Electronics from a recognized University or institution.”
