**Subject: Advertisement for filling of the post of State Chief Information Commissioner in the Odisha Information Commission.**

Government of Odisha have constituted the Odisha Information Commission to exercise the powers conferred on and perform the assigned functions under the Right to Information Act, 2005. The powers and functions of the State Chief Information Commissioner in the Odisha Information Commission are as per the provisions contained in chapter - V of the Right to Information Act, 2005.

2. It is proposed to fill up the post of the State Chief Information Commissioner in the Commission as per the following eligibility criteria under the Right to Information Act, 2005 and Right to information (Amendment Act-2019)

I. The candidates shall be persons of eminence in public life with wide knowledge and experience in law, science and technology, social service, management, journalism, mass-media or administration and governance.

II. The candidates shall not be a Member of Parliament or Member of the Legislature of any State or Union Territory, as the case may be, or hold any other office of profit or connected with any political party or carrying on any business or pursuing any profession. It is clarified that cessation/termination of holding of office of profit, pursuing any profession or carrying any business is a condition precedent to the appointment of a person as the State Chief Information Commissioner.

III. The candidates who have already attained the age of 65 years as on the date of issue of this advertisement shall not be eligible to apply for this post.

3. The salary, allowances and other terms and conditions of service of the State Chief Information Commissioner shall be as per the provisions contained in the Right to Information (Term of Office, Salaries, Allowances and Other Terms and Conditions of Service of Chief Information Commissioner, Information Commissioners in the Central Information Commission, State Chief Information Commissioner and State Information Commissioners in the State Information Commission) Rules, 2019.

4. The candidates fulfilling the aforementioned criteria and interested for appointment to the post of the State Chief Information Commissioner may send their particulars duly filled in the enclosed prescribed pro- forma along with Annexure-I in a sealed envelope superscribed with **“APPLICATION FOR THE POST OF STATE CHIEF INFORMATION COMMISSIONER”** by speed post/ registered post only addressing the **Director, Information & Public Relations Department, Lok Sampark Bhawan, Unit-V, Bhubaneswar-751001 on or before 02.11.2024, 05:30P.M.** The application received after due date shall not be considered.

The candidates serving under the State/Central Government or any other Organization should send their particulars through proper channel (Administrative Ministry/Department of State – UT/Central Government or the Controlling office respectively).

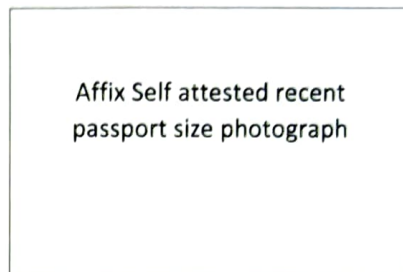
