ADVERTISEMENT

Subject: Advertisement for filling up of four posts of State Information Commissioners in the Odisha Information Commission.

The Government of Odisha have constituted the Odisha Information Commission to exercise the powers conferred on and to perform the functions assigned thereto under the Right to Information Act, 2005. The powers and functions of State Information Commissioner in the Odisha Information Commission are as per the provisions contained in chapter - V of the Right to Information Act, 2005.

2. It is proposed to fill up four posts of State Information Commissioner in the Commission as per the following eligibility criteria under the Right to Information Act, 2005 and Right to Information (Amendment Act)-2019.

I. The candidates shall be persons of eminence in public life with wide knowledge and experience in law, science and technology, social service, management, journalism, mass-media or administration and governance.

II. The candidates shall not be a Member of Parliament or Member of the Legislature of any State or Union Territory, as the case may be, or hold any other office of profit or connected with any political party or carrying on any business or pursuing any profession. It is clarified that cessation/termination of holding the office of profit, pursuing any profession or carrying any business is a condition precedent to the appointment of a person as State Information Commissioner.

III. The candidates who have already attained the age of 65 years as on the date of issue of this advertisement shall not be eligible to be considered for applying for this post.

3. The salary, allowances and other terms and conditions of service of the State Information Commissioner shall be as per the provisions contained in the Right to Information (Term of Office, Salaries, Allowances and Other Terms and Conditions of Service of Chief Information Commissioner, Information Commissioners in the Central Information Commission, State Chief Information Commissioner and State Information Commissioners in the State Information Commission) Rules, 2019.

4. The candidates fulfilling the aforementioned criteria and interested for appointment to the post of State Information Commissioner may send their particulars in the duly filled in pro forma as prescribed and enclosed along with Annexure-I in a sealed envelope superscribing "**APPLICATION FOR THE POST OF STATE INFORMATION COMMISSIONER VIDE ADVT NO-15829 DATED-19/11/2024**" by speed post/ registered post only addressing the **Director, Information & Public Relations Department, Lok Sampark Bhawan, Unit-V, Bhubaneswar-751001 by 24.12.2024, 5:30P.M.**
