SRI SATYANARAYAN SETHY, AEE, KOTPADA BLOCK, DIST-KORAPUT ARRESTED BY ODISHA VIGILANCE IN DA CASE. DA TO THE TUNE OF 268% OF KNOWN SOURCES OF INCOME INCLUDING 2 FLATS (1 BENAMI FLAT), 3 FARMS SPREAD OVER 14 ACRES, 49 VALUABLE PLOTS (17 BENAMI PLOTS), GOLD APPROX 940 GMS, SILVER APPROX 2.5 KG, CASH RS.5.48 LAKHS, DEPOSITS OVER RS.60.92 LAKHS, 1 BENAMI FOUR WHEELER (TATA HARRIER), ETC UNEARTHED.

Today i.e. on 20.06.2026, Sri Satyanarayan Sethy, Assistant Executive Engineer (AEE), Kotpada Block, Dist-Koraput, was arrested by Odisha Vigilance and forwarded to the Hon'ble Court of Special Judge, Vigilance, Jeypore for possession of disproportionate assets (DA) to the tune of 268% of his known sources of income, which he could not account for satisfactorily. In this connection, Koraput Vigilance PS Case No.11 dated 20.06.2026 was registered against Sri Satyanarayan Sethy, Assistant Executive Engineer, his spouse and his in-law U/s 13(2) r/w 13(1)(b)/12 PC Amendment Act, 2018.

During house searches, the following movable and immovable assets worth crores were unearthed in the name of **Sri Satyanarayan Sethy, Assistant Executive Engineer and his family members;**

- 1) **One 2-BHK Flat vide Flat No.6/B.6-14 with area approx 1000 Sqft in Ground floor, Block- B/6, Plot No.132 in Hi-tech Plaza under Madhipur Mauza, Jatani, Khordha.**

- 2) One 2-BHK benami flat vide flat No.409 located at Golden Height Residence apartment at PR Peta, Indira Chowk, Jeypore, Koraput purchased in name of his close associate.
- 3) 3 farms spread over 14 acres (mango & eucalyptus plantations) located at Mouza-Taragaon, Boriguma Tahasil, Dist-Koraput.
- 4) 49 valuable plots under Jeypore, Koraput Boriguma, Kotpad, Patangi Tahasils in Koraput district, of which 17 plots are benami plots purchased in name of his relative.
- 5) Cash Rs.5,48,000/-(picture given below).
- 6) Gold jewellery 940.66 gms & silver ornaments 2.493 Kg.
- 7) Deposits Rs.60,92,548/-.
- 8) 1 benami four wheeler (TATA Harrier) & 1 benami two wheeler.
- 9) Household articles worth around Rs.5.52 Lakhs.

After thorough search, inventory and further enquiry, the income, expenditure and assets of Sri Satyanarayan Sethy, Assistant Executive Engineer, Kotpada Block, Dist-Koraput were calculated and he was found in possession of disproportionate assets which were 268% in excess of his known sources of income.

Investigation of the case is in progress.
