SRI DHANURDHAR BISWAL, ESTABLISHMENT OFFICER-CUM-OFFICE SUPERINTENDENT, VIMSAR, BURLA, SAMBALPUR ARRESTED BY ODISHA VIGILANCE IN DA CASE. DA TO THE TUNE OF 234% OF KNOWN SOURCES OF INCOME INCLUDING 2 BUILDINGS (1 MULTI STOREYED BUILDING OF 1700 SQFT), 32 VALUABLE PLOTS, CASH OVER RS.19.80 LAKHS, DEPOSITS RS.48.09 LAKHS, 2 HYVA TRUCKS, 2 TRACTORS, 1 FOUR WHEELER, ETC UNEARTHED.

Today i.e. on 01.07.2026, Sri Dhanurdhar Biswal, Establishment Officer-cum-Office Superintendent, Vimsar, Burla, Sambalpur, **was arrested by Odisha Vigilance** and forwarded to the Hon'ble Court of Special Judge, Vigilance, Sambalpur for possession of disproportionate assets (DA) to the tune of 234% of his known sources of income, which he could not account for satisfactorily. In this connection, Sambalpur Vigilance PS Case No.09 dated 01.07.2026 was registered against Sri Dhanurdhar Biswal, Establishment Officer-cum-Office Superintendent, Vimsar, Burla, Sambalpur and his spouse U/s 13(2) r/w 13(1)(b)/12 PC Amendment Act, 2018.

During house searches, the following movable and immovable assets **worth crores** were unearthed in the name of **Sri Dhanurdhar Biswal and his family members**;

- 1) Residential double storeyed building with area approx 1700 Sqft. located at Dhankauda, Sambalpur.**
- 2) One building located at Gudesinga, Sambalpur.**
- 3) 32 valuable plots on the outskirts of Sambalpur town.**
- 4) Cash Rs.19,80,290/-.**

- 5) Gold jewellery 83.05 gms.
- 6) Deposits Rs.48,09,395/-.
- 7) 2 Mahindra Hyva Trucks, 2 Mahindra Tractors, 1 Trailer, 1 four wheeler (Renault Kiger) & 4 two wheelers.
- 8) Gold & household articles worth around Rs.13.20 Lakhs.

After thorough search, inventory and further enquiry, the income, expenditure and assets of Sri Dhanurdhar Biswal, Establishment Officer-cum-Office Superintendent, VIMSAR, Burla, Sambalpur were calculated and he was found in possession of disproportionate assets which were 234% in excess of his known sources of income.

Investigation of the case is in progress.
